#### PROJECT EXPERIENCE:

- For a 2010 contract with Army Corps of Engineers for \$5848 (Best Value) QC Analytical is providing certified laboratory results for sediment analysis of Rice Lake/ Illinois River. Results of containment levels will determine budgeting for dredging or hauling procedures.
- For over 20 years Rock Island Integrated Services, the primary facilities maintenance contractor to the US Government at the Rock Island Arsenal Island (RIA), has utilized QC Analytical Services (Sub). Routine NPDES tests and other environmental tests are completed as needed. Savings exceed \$275,000 by subcontracting.
- In 2006 RIA could safely allow employees to continue working in Manufacturing Complex after completing testing of unknown odor. QC Analytical identified the formulation which was communicated to supplier. A safer product was used to ensure the highest quality working conditions for employees.
